SANCTIONS AND ACCESS TO LIMITED TRAFFIC AREAS (ZTL)

Any penalties and responsibilities deriving from traffic law infringements are to be paid by the driver signing this declaration of responsibility.

Access to urban areas where traffic is limited (ZTL) is not allowed.

We furthermore inform you that, in the event of infringements punishable by the deduction of points from your driving licence, TELS SOCIETA' COOPERATIVA is required to communicate your personal data to the Authorities where requested, being the driver of the vehicle at the time of the infringement, within 30 days of receiving notice of violation.

Smoking while driving the vehicle or riding on it as a passenger is forbidden.

In the event of any problems or incidents occurring with or to the vehicle, you should immediately notify TELS SOCIETA' COOPERATIVA to allow us to properly file insurance reports.

The motorcycle is covered for civil liability, fire and theft insurance. Insurance coverage for the driver in the event of an accident leading to permanent disability or death is included up to a maximum of 50,000 euros, with a 10% deductible on the percentage of disability.

It is strictly forbidden to allow third parties to use the vehicle and/or take it abroad.

DEPOSITS

A **deposit of 100.00 euros in cash** is requested when picking up the vehicle. This deposit will be returned if there have been no damages. The deposit will be cashed in if we have to incur any expenses in the event the keys or the registration documents of the vehicle are lost and/or to cover damages, including those to third parties which involve the payment of an insurance deductible.

When picking up the vehicle, you will be requested to pay a **deposit of 10.00 euros** in cash, which will be entirely refunded if the vehicle is returned with the same amount of fuel as when it was picked up. Otherwise, the deposit of 10.00 euros will not be refunded.
